

CUSTOMS REGULATIONS AND INFORMATION FOR IMPORTS

HOUSEHOLD GOODS AND PERSONAL EFFECTS

Documents Required

- Bill of Lading (OBL) / Air Waybill (AWB)
- Packing list
- Pro-forma Invoice (ORIGINAL MUST ARRIVE WITH THE SHIPMENT!!!)
- Copy of Passport (photo page)
- Copy of ID (if returning Azeri citizen)
- Letter of Employment (on Company's or Embassy's letterhead)
- Photographs for all cultural items (carpets, paintings, musical instruments, ornaments, souvenirs, copper items, statues, swords, masks etc.)
- Copy of Diplomatic Card (If Diplomats)

Specific Information

- Import of personal effects to Azerbaijan is subject to payment of 36% import duties/levy and VAT. Diplomatic passport holders and employees of Oil & Gas companies which have "Customs Duty Exemption Certificate" will be allowed for duty free entry, in all other cases 36% import duties apply. Returning Azerbaijan citizens do not hold any rights at all in terms of import duties, import of personal effects is subject to full duties, levies and vat. Customs duties, levies and vat is calculated at approx. 36% of CIF value of the shipment (COST+INSURANCE+FREIGHT)

Note: It is recommended that documents showing the true value of the goods do not be sent with the shipment to avoid the payment of heavy Customs duties.

MOTOR VEHICLES

Documents Required

- Original Technical Passport / Title
- Copy of Passport
- Copy of Visa
- OBL / AWB
- Vehicle Registration
- Copy of Diplomatic card (Diplomats)
- Employment confirmation (Diplomats)

Specific Information

Imported car or bike must comply with EURO IV ecological standard. It needs to be checked and confirmed by customs officials using vehicle's unique VIN number. In case if vehicle does not comply with EURO IV standard it will not be allowed for import.

EURO IV Ecological standard applies to ALL even to DIPLOMATS!!!

There will be no issues if vehicle conforms to EURO 4 standard and copies of required documents provided before vehicle's arrival to Baku, Azerbaijan.

Import of personal effects and vehicles to azerbaijan (**for NON-diplomats**) is subject to payment of import customs levies, duties and vat.

Valid diplomatic passport and diplomatic Card authorized By MOFA Azerbaijan are required for duty free entry of HHG and POV

- Only Diplomats can import vehicles without deposits on a duty free basis.
- Vehicles can be imported for a maximum of 2 years duty and tax free on a temporary basis; temporary import is subject to a refundable deposit; the exact amount of the deposit will be determined by Customs authorities only after inspection and depending on the condition and model of the vehicle (foreigners).
- The permanent import of vehicles is subject to the payment of Customs duties per Customs tariff (foreigners).
- Right-hand drive cars and cars with tinted glass cannot be imported.

PETS

Documents Required

- Certificate of Vaccination
- Veterinary Health Certificate
- Pet Passport

Specific Information

- Cats, dogs, and most species of birds must be accompanied by the Veterinary Health Certificate, issued with 10 days of arrival.
- Pigeons cannot be imported.

RESTRICTED / DUTIABLE ITEMS

- Precious jewelry, stones and currency can be imported only as accompanied baggage and must be declared with Customs authorities at the time of arrival.
- Wine and spirits (limit of 3 L per shipment based on personal consumption). Tax and duties are based upon the percentage of alcohol:
 - From 1 euro per liter up to 2 euro per liter Customs duty
 - 25% of CIF value
 - 18% of VAT of CIF value
 - 0.5% of CIF value
 - Customs fee

PROHIBITED ITEMS

- Weapons of all kinds
- Pornography
- Narcotics
- Toxic and radioactive materials
- Wildlife objects
- Food items
